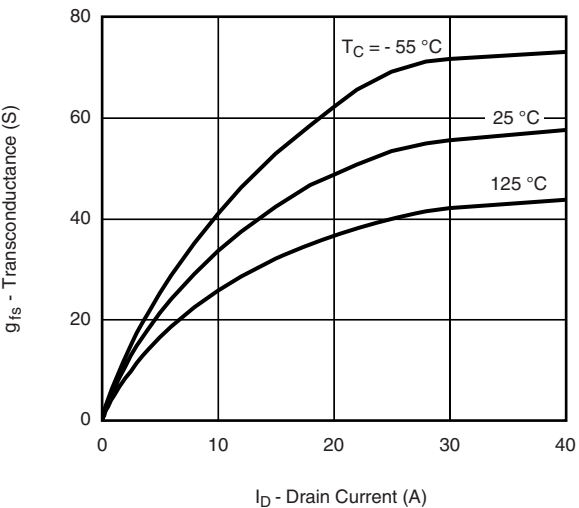

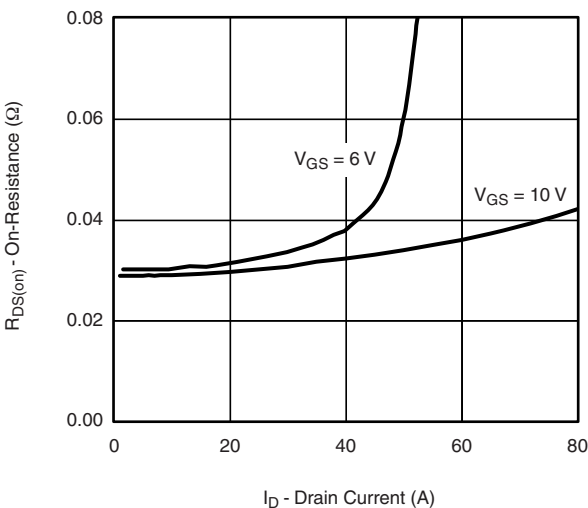

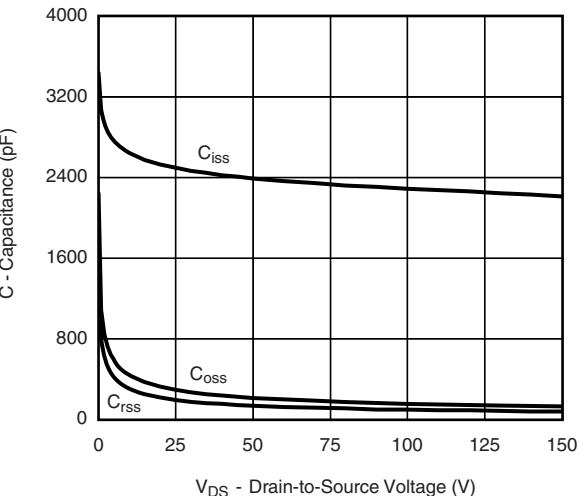

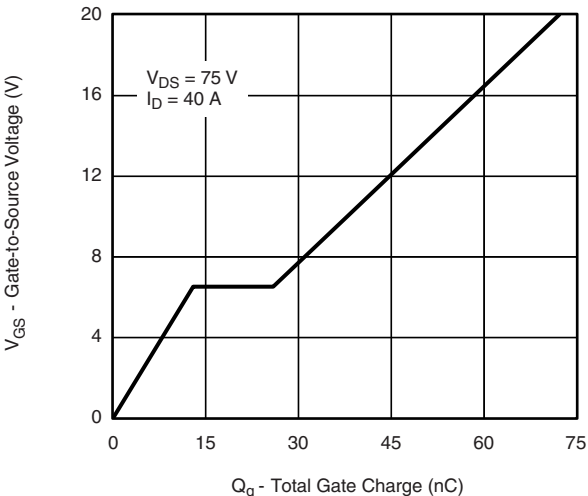

**On-Resistance vs. Drain Current**

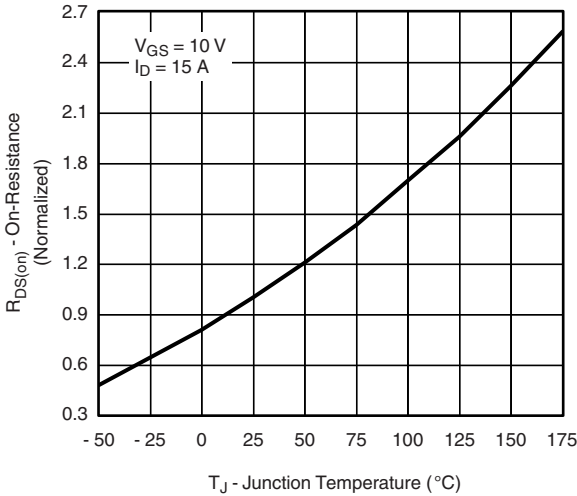

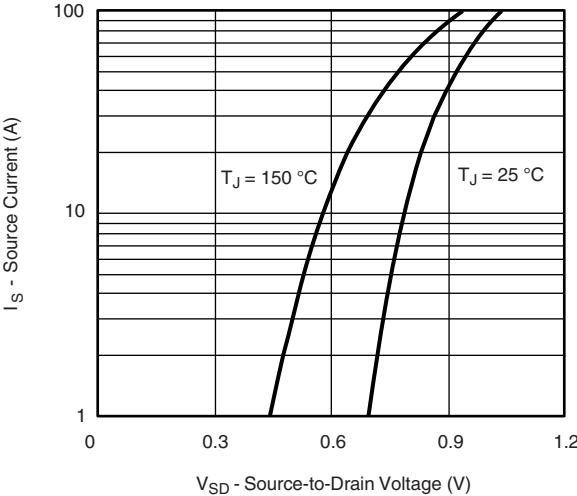

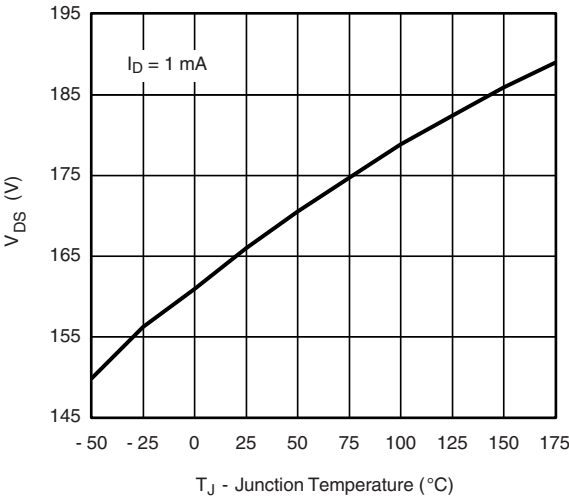

**Source-Drain Diode Forward Voltage**

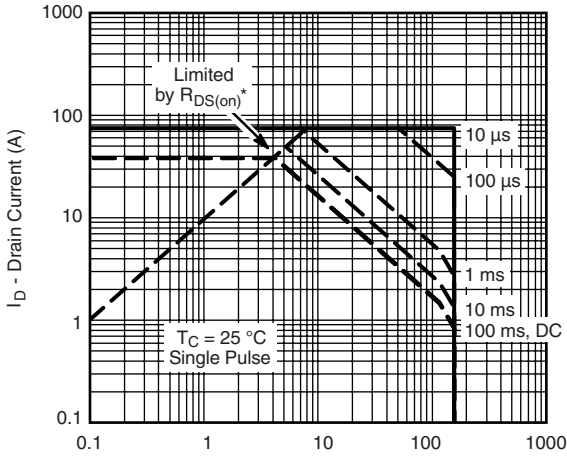


**Drain Source Breakdown vs. Junction Temperature**

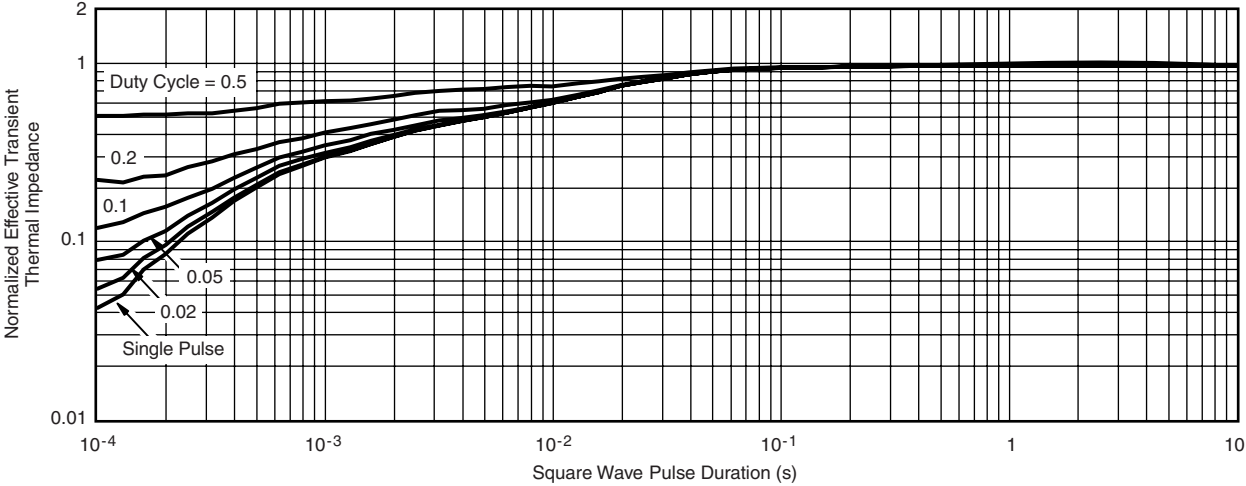

Maximum Avalanche and Drain Current vs. Case Temperature

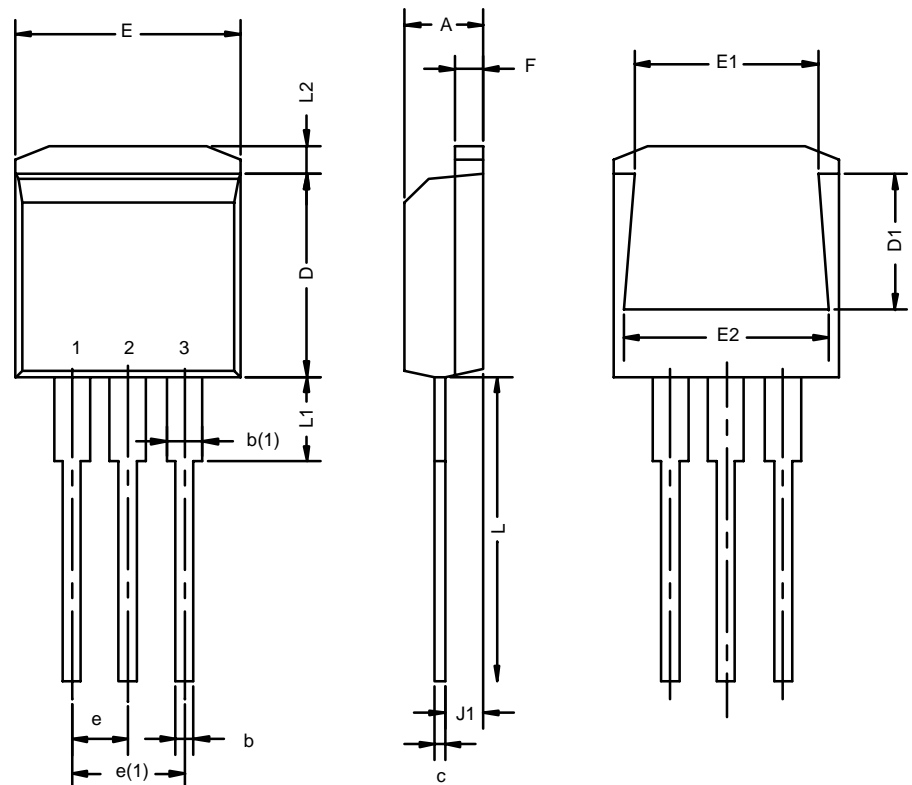
