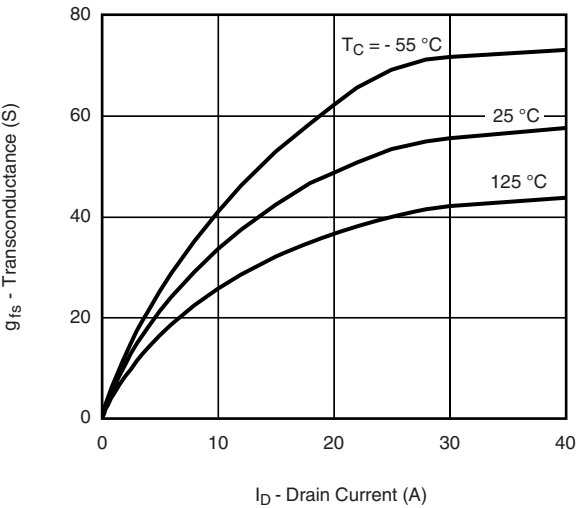

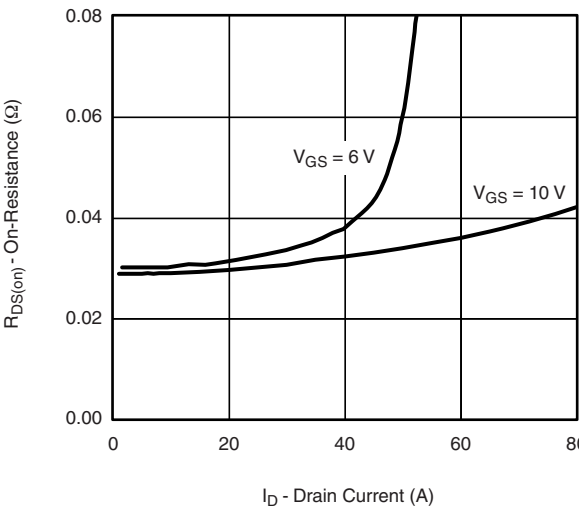

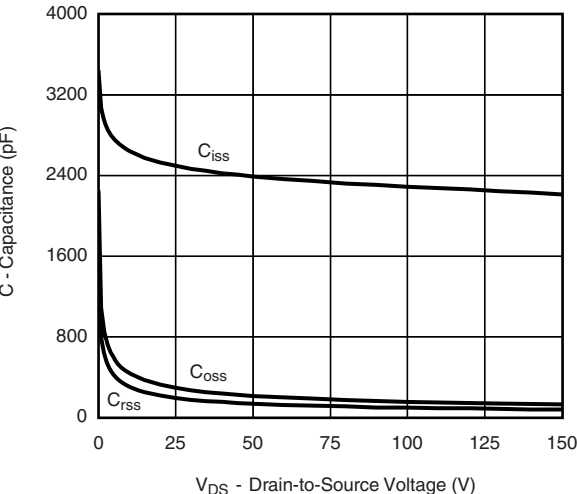

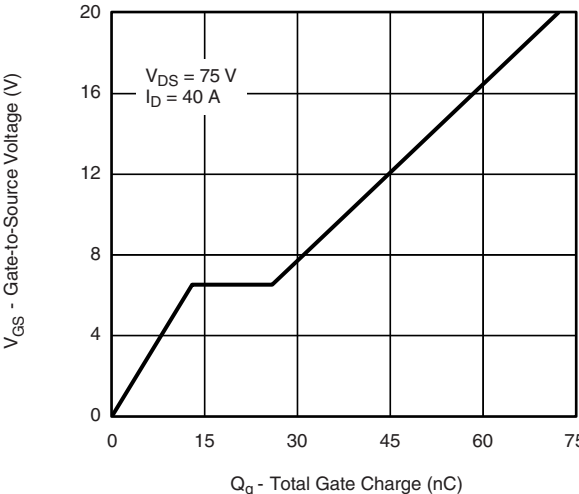
Transconductance



On-Resistance vs. Drain Current

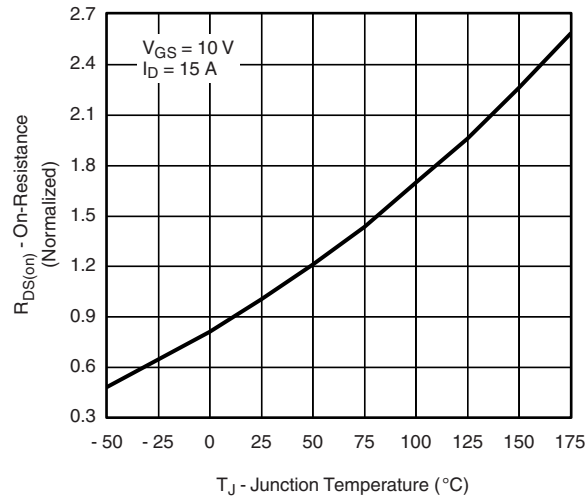

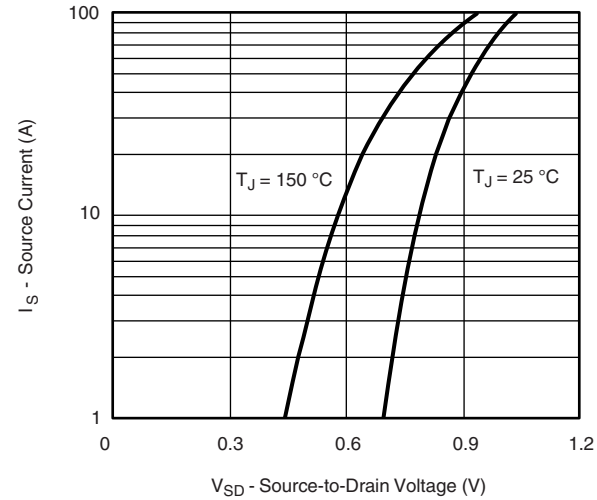

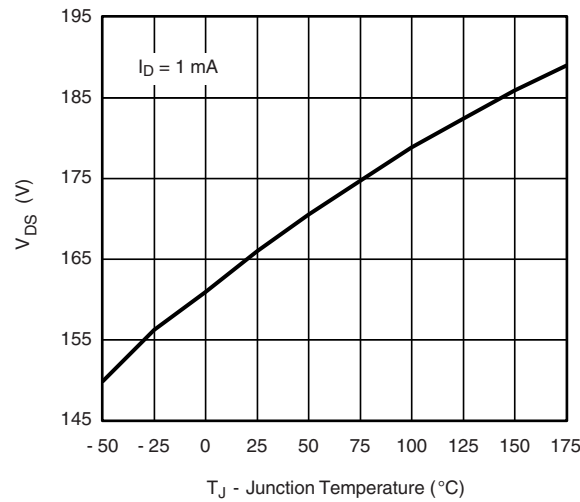

Source-Drain Diode Forward Voltage

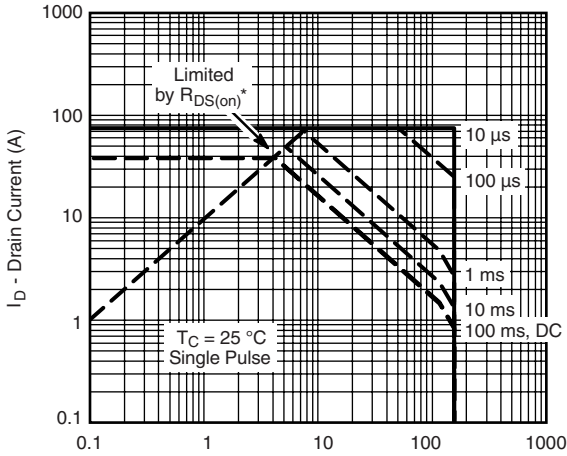


**Drain Source Breakdown
vs. Junction Temperature**

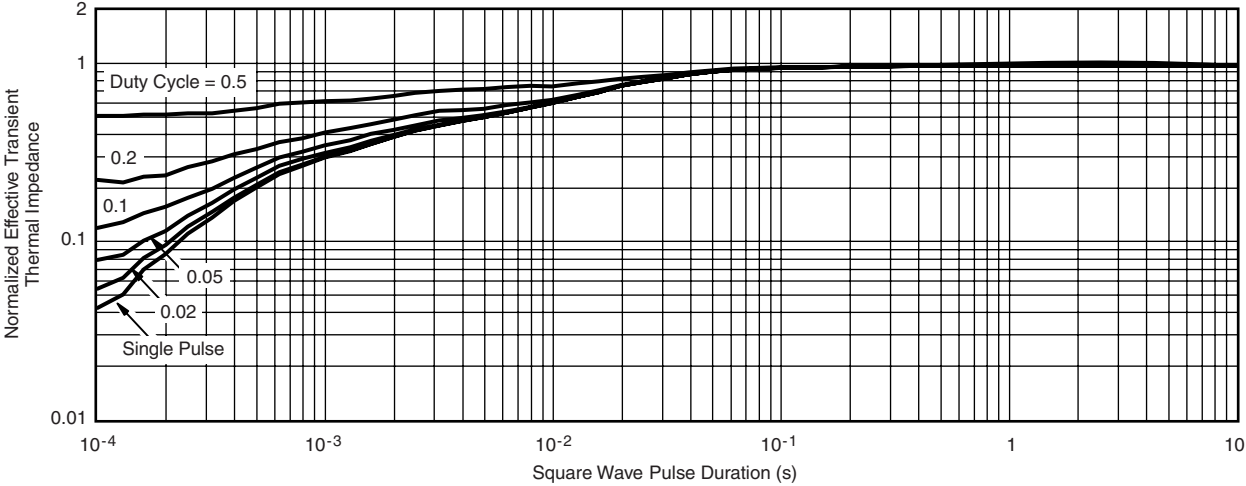

Maximum Avalanche and Drain Current vs. Case Temperature

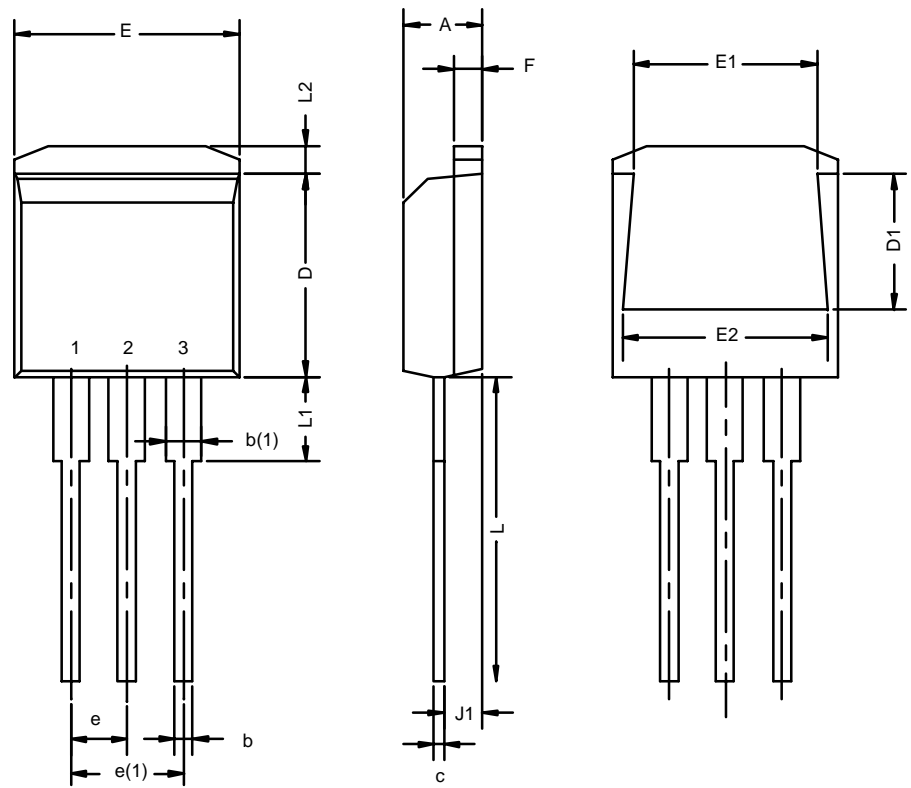
