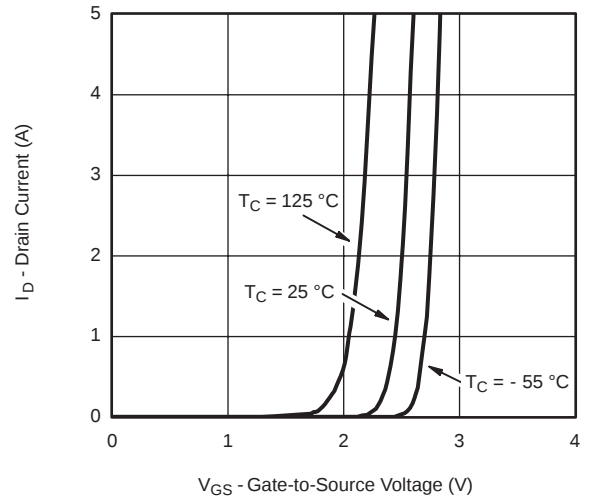

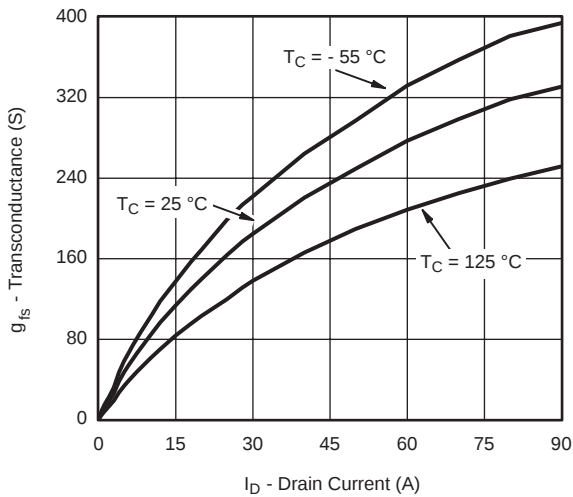

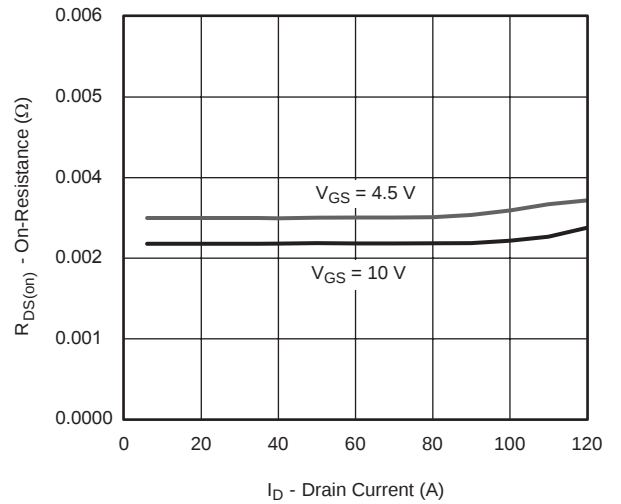
Output Characteristics



Transfer Characteristics



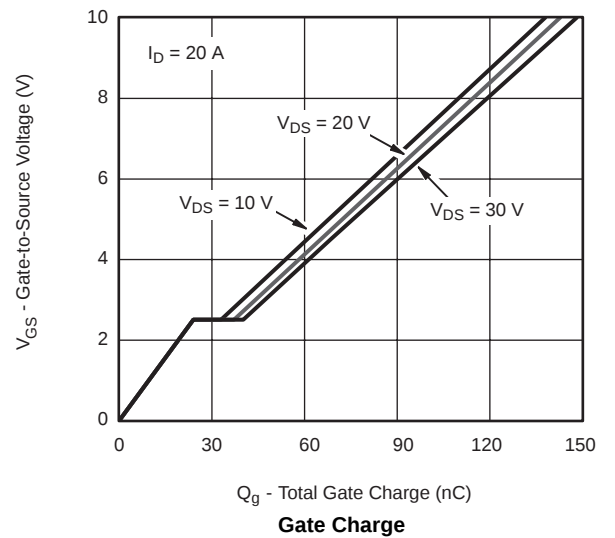
Transconductance



On-Resistance vs. Drain Current



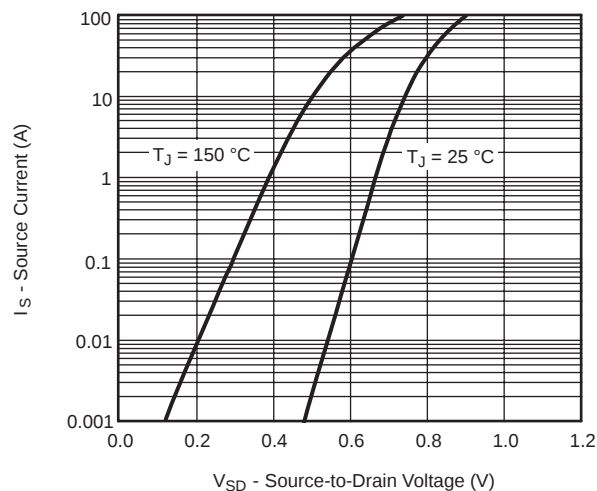

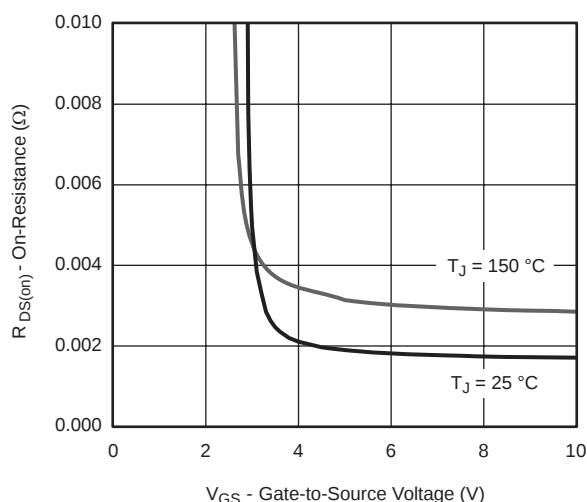

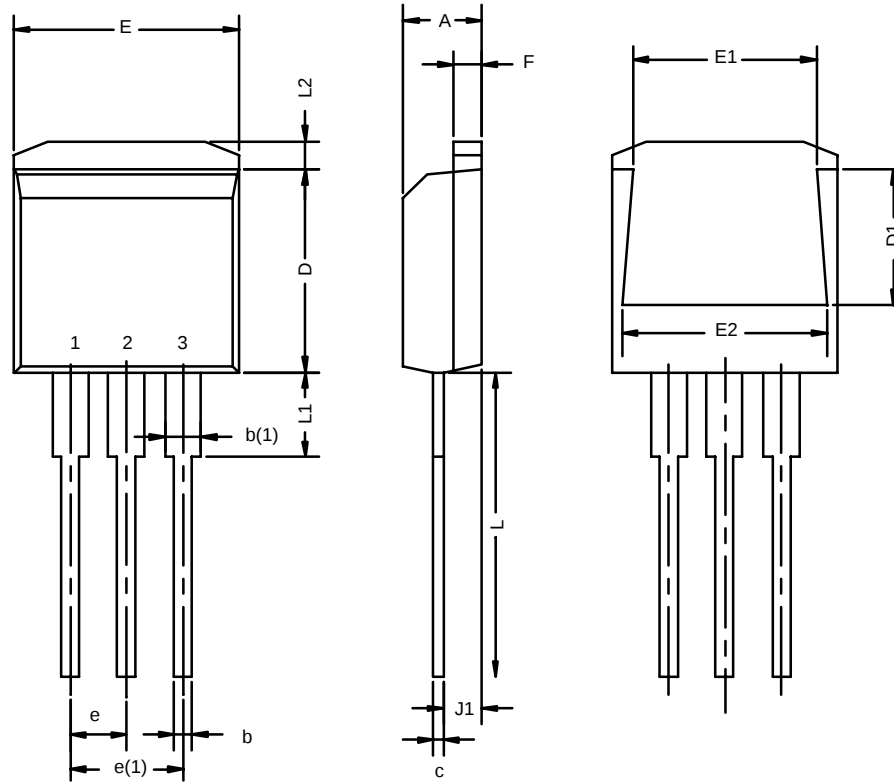
