



## **TYPICAL CHARACTERISTICS** (T<sub>A</sub> = 25 °C, unless otherwise noted)










#### On-Resistance vs. Junction Temperature




**Source Drain Diode Forward Voltage**






#### Safe Operating Area

#### Normalized Thermal Transient Impedance, Junction-to-Case


