




 V_{DS} - Drain-to-Source Voltage (V) $\label{eq:capacitance}$


 $R_{DS(on)}$ vs. Drain Current







Maximum Drain Current vs. Ambient Temperature




Normalized Thermal Transient Impedance, Junction-to-Case






