






Source-Drain Diode Forward Voltage




Threshold Voltage

Single Pulse Power, Junction-to-Ambient








Current Derating*









Normalized Thermal Transient Impedance, Junction-to-Ambient




Normalized Thermal Transient Impedance, Junction-to-Foot
