 $R_{DS(on)}$  vs.  $V_{GS}$  vs. Temperature















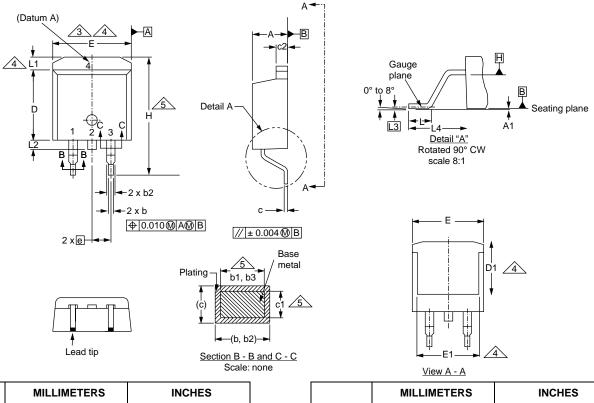
#### TYPICAL CHARACTERISTICS (25 °C, unless otherwise noted)

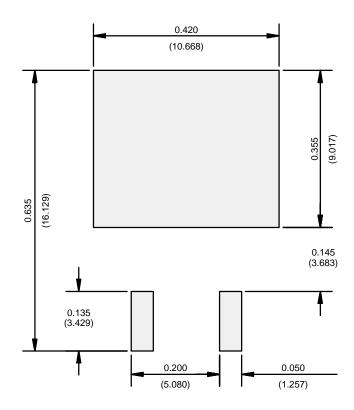
