






 $R_{DS(on)}$ vs. Drain Current




Gate Charge

On-Resistance vs. Junction Temperature









Maximum Drain Current vs. Ambient Temperature




Normalized Thermal Transient Impedance, Junction-to-Case





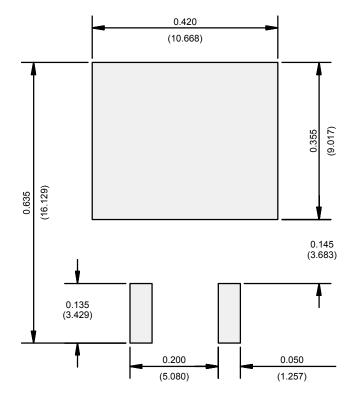
