









On-Resistance vs. Junction Temperature

On-Resistance vs. Gate-to-Source Voltage




 $T_{J} \text{ - Junction Temperature (°C)} \\$ **Drain Source Breakdown vs. Junction Temperature**


Normalized Thermal Transient Impedance, Junction-to-Ambient




