





#### TYPICAL CHARACTERISTICS (25 °C, unless otherwise noted)


 $V_{GS}$  - Gate-to-Source Voltage (V)





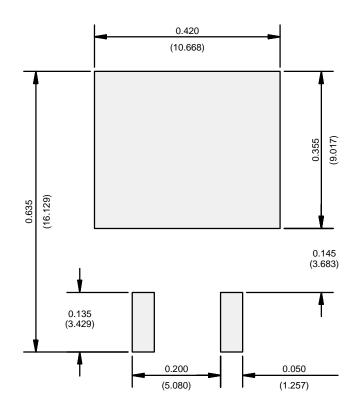
