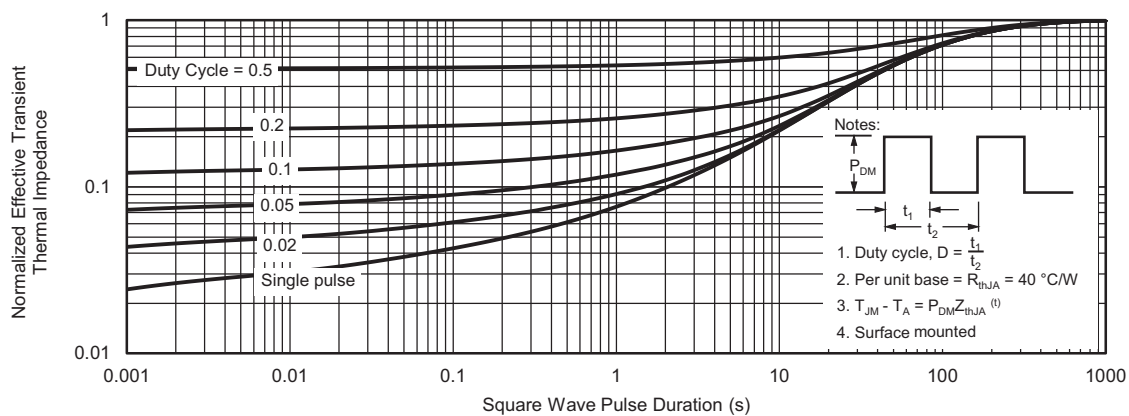

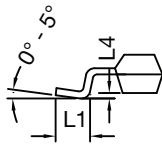
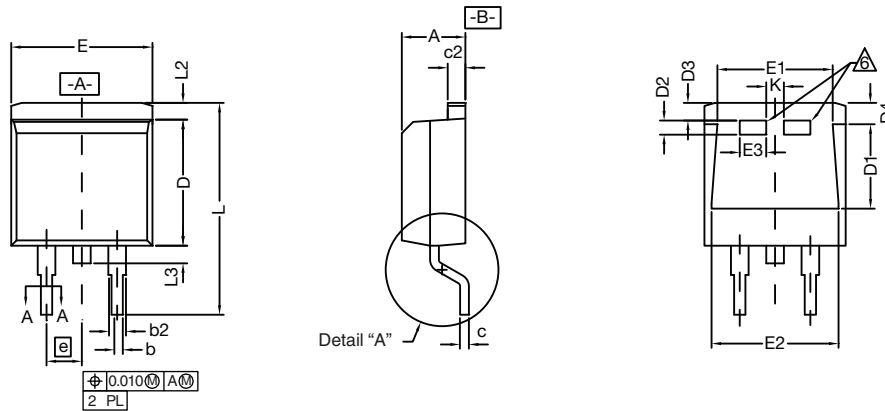

Normalized Thermal Transient Impedance, Junction-to-Case

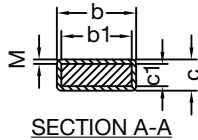

DETAIL A (ROTATED 90°)



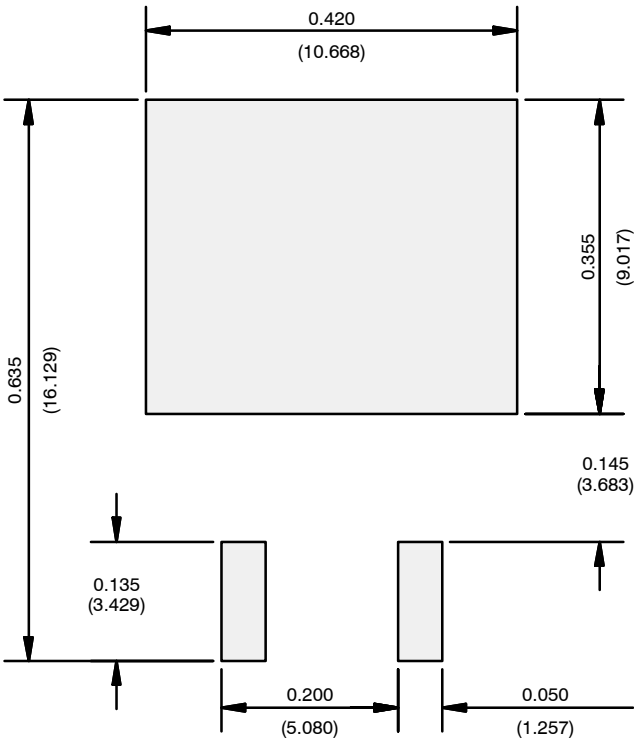
