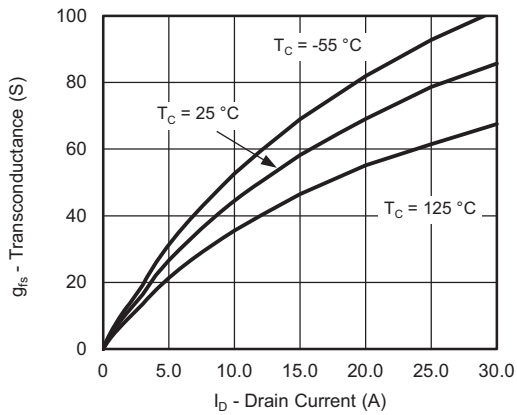

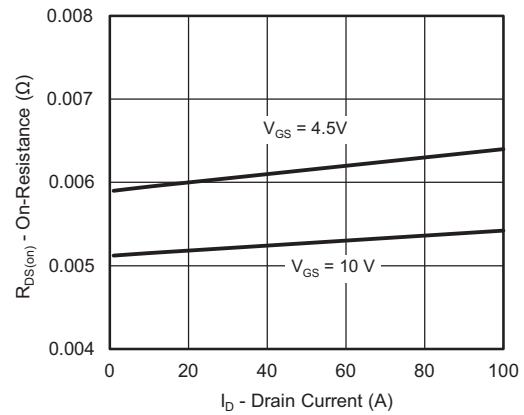

On-Resistance vs. Drain Current

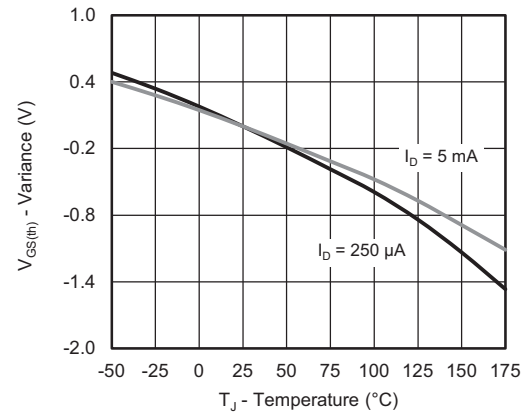


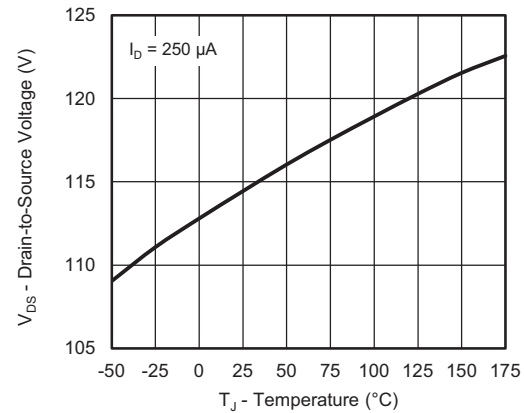

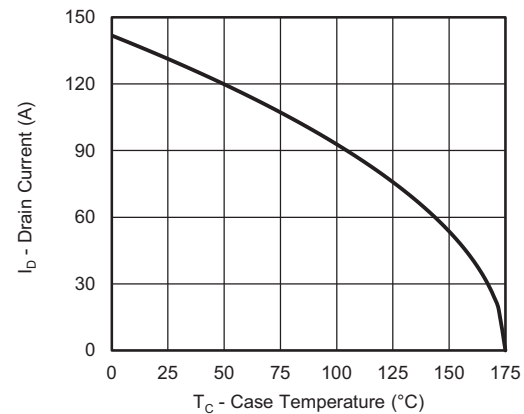

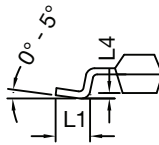

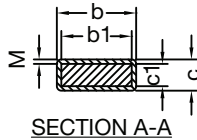

DETAIL A (ROTATED 90°)



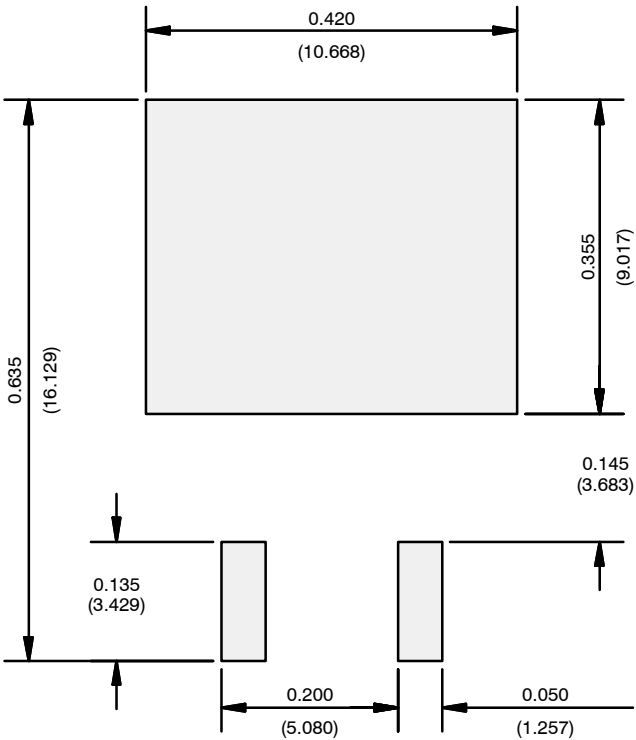
