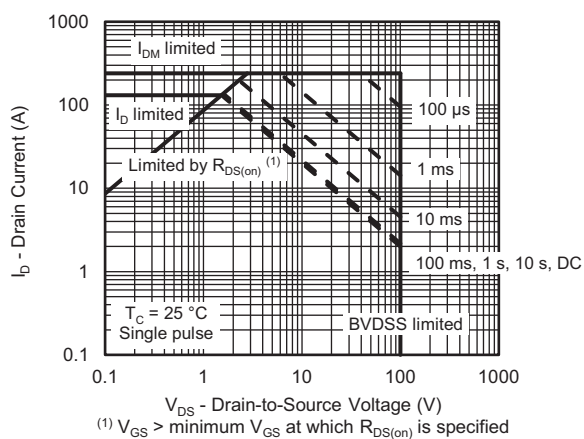
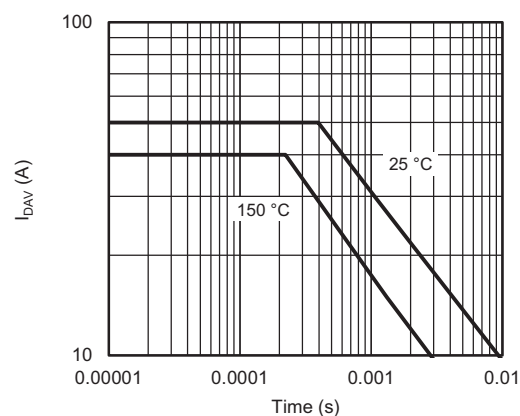
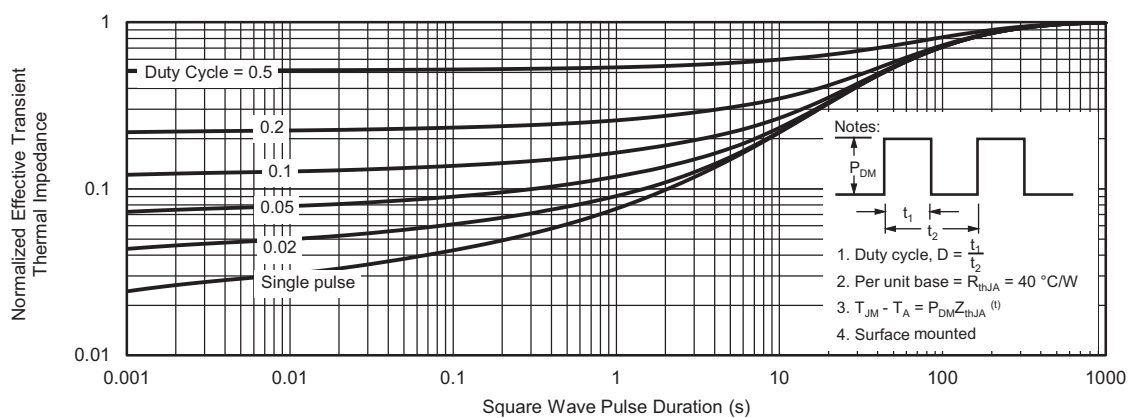
Drain Source Breakdown vs. Junction Temperature



Source Drain Diode Forward Voltage



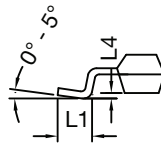

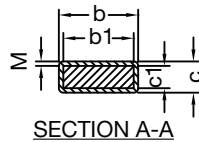
