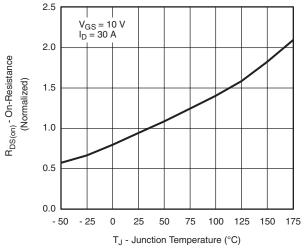

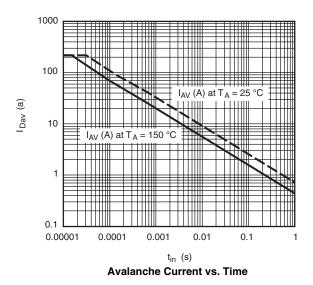




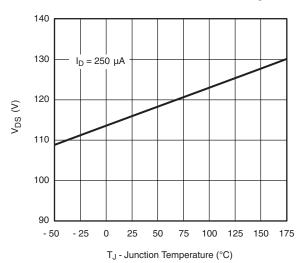

Source-Drain Diode Forward Voltage

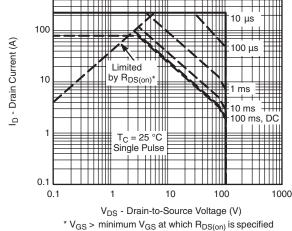


T_J - Drain-Source Breakdown vs. Junction-Temperature

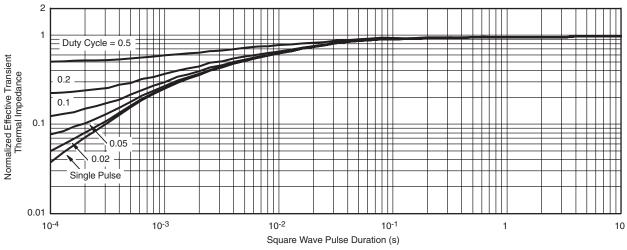

Normalized Thermal Transient Impedance, Junction-to-Case

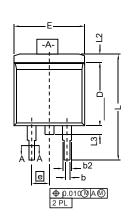
