



TYPICAL CHARACTERISTICS (T_A = 25 °C, unless otherwise noted)






TYPICAL CHARACTERISTICS ($T_A = 25 \, ^{\circ}\text{C}$, unless otherwise noted)







On-Resistance vs. Junction Temperature

On-Resistance vs. Gate-to-Source Voltage




Drain Source Breakdown vs. Junction Temperature


Normalized Thermal Transient Impedance, Junction-to-Ambient

Normalized Thermal Transient Impedance, Junction-to-Case




