






TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted

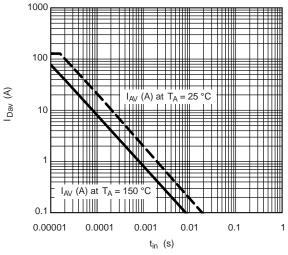




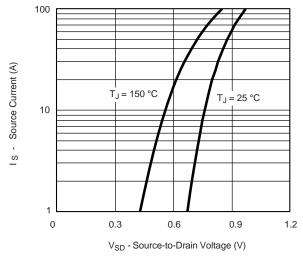


On-Resistance vs. Junction Temperature



Avalanche Current vs. Time




Source-Drain Diode Forward Voltage



Maximum Avalanche and Drain Current vs. Case Temperature








Normalized Thermal Transient Impedance, Junction-to-Case


