






R_{DS(on)} vs. Drain Current





Source-Drain Diode Forward Voltage



Maximum Drain Current vs. Ambient Temperature








Normalized Thermal Transient Impedance, Junction-to-Case

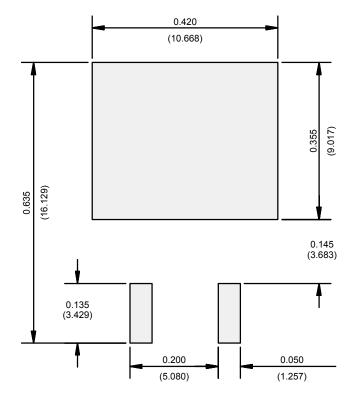
