









**Transconductance** 






**Transfer Characteristics** 



R<sub>DS(on)</sub> vs. Drain Current



Forward Diode Voltage vs. Temperature




Threshold Voltage



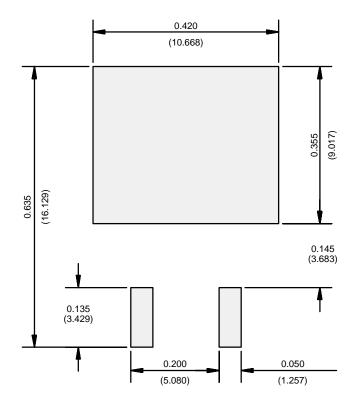
