






#### On-Resistance vs. Junction Temperature

Source-Drain Diode Forward Voltage




T<sub>J</sub> - Drain-Source Breakdown vs. Junction-Temperature



**Maximum Avalanche and Drain Current** vs. Case Temperature








Normalized Thermal Transient Impedance, Junction-to-Case
