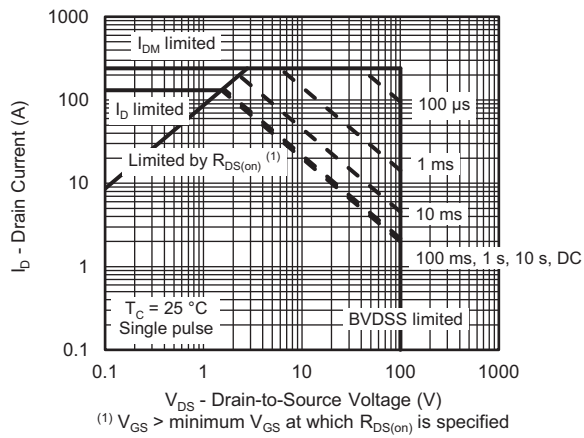

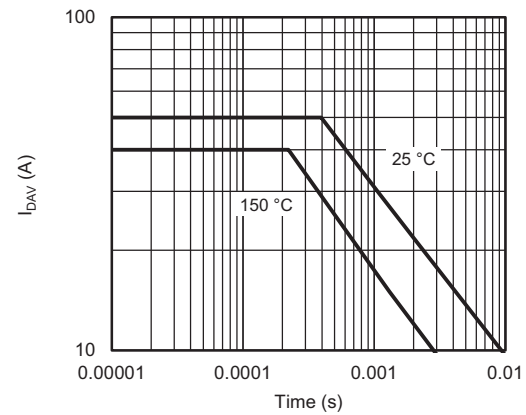

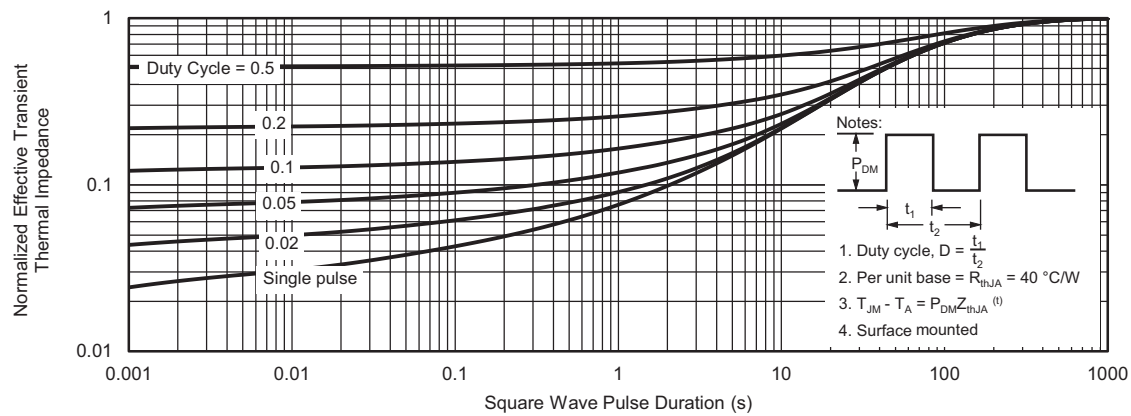

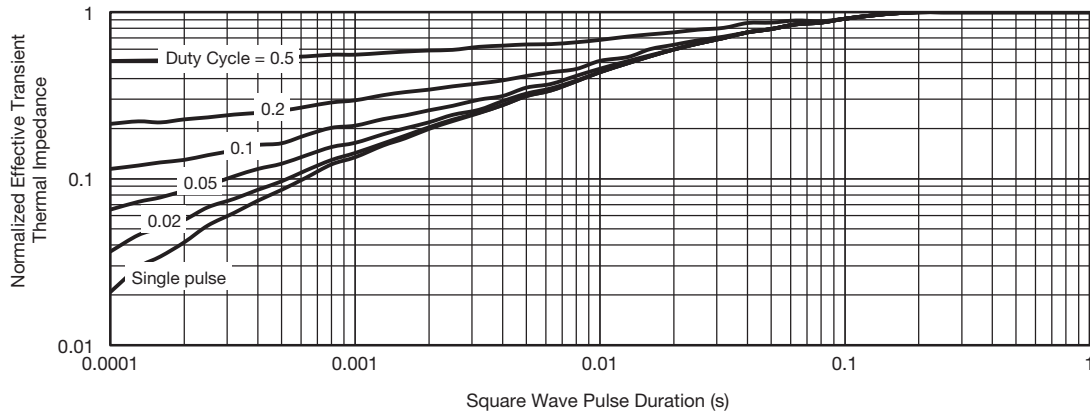
Safe Operating Area

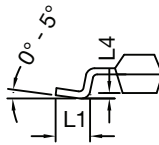
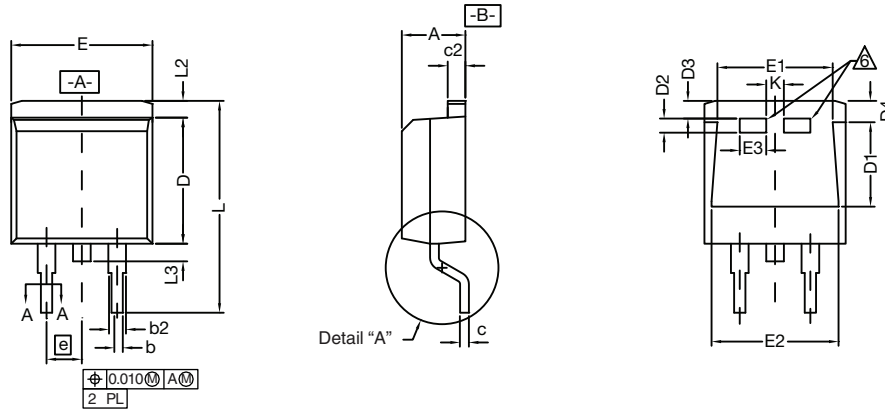


Normalized Thermal Transient Impedance, Junction-to-Ambient

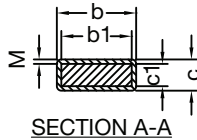

DETAIL A (ROTATED 90°)



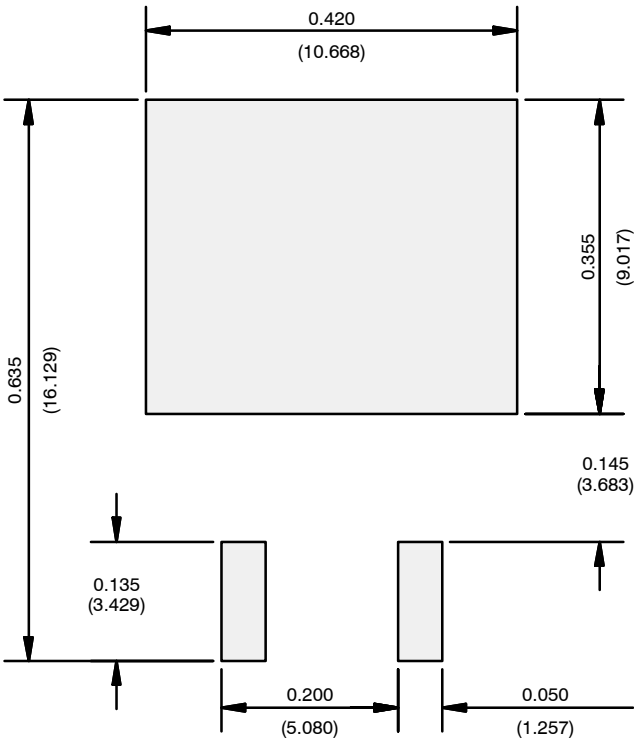
