






TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted








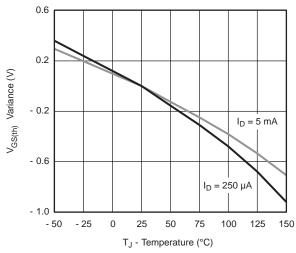
On-Resistance vs. Junction Temperature

Threshold Voltage






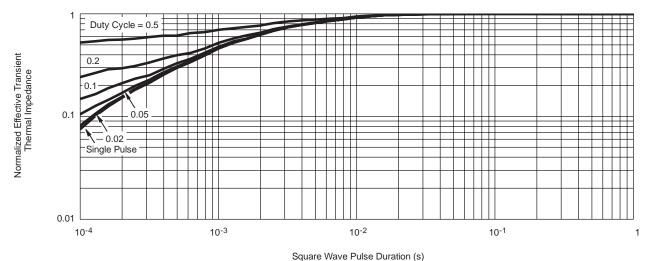




Normalized Thermal Transient Impedance, Junction-to-Case
