






On-Resistance vs. Drain Current








Source-Drain Diode Forward Voltage



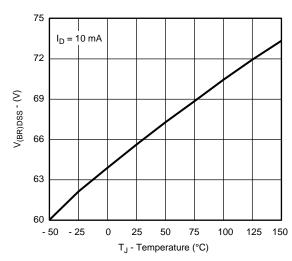
Single Pulse Avalanche Current Capability vs. Time



On-Resistance vs. Gate-to-Source Voltage




On-Resistance vs. Gate-to-Source Voltage




Drain-Source Breakdown Voltage vs. Junction Temperature








Threshold Voltage




Max. Drain Current vs. Case Temperature



Power Derating, Junction-to-Case







Normalized Thermal Transient Impedance, Junction-to-Case
