









#### On-Resistance vs. Junction Temperature



**Avalanche Current vs. Time** 




Source-Drain Diode Forward Voltage



Drain Source Breakdown vs. Junction Temperature







Maximum Avalanche and Drain Current vs. Case Temperature






Normalized Thermal Transient Impedance, Junction-to-Case


