



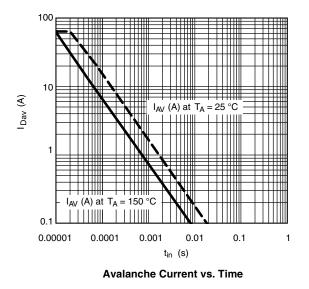









**On-Resistance vs. Junction Temperature** 





Source-Drain Diode Forward Voltage




Drain Source Breakdown vs. Junction Temperature




Normalized Thermal Transient Impedance, Junction-to-Case
