






Gate Current vs. Gate-Source Voltage








On-Resistance vs. Gate-to-Source Voltage



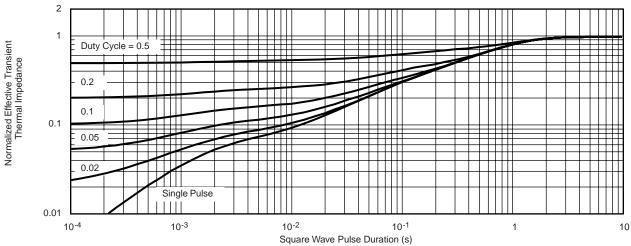
Safe Operating Area, Junction-to-Case




Normalized Thermal Transient Impedance, Junction-to-Foot


