


 $\label{eq:VGS} V_{GS} \text{ - Gate-to-Source Voltage (V)}$  Gate Current vs. Gate-Source Voltage











#### On-Resistance vs. Gate-to-Source Voltage




Single Pulse Power



Threshold Voltage




Safe Operating Area, Junction-to-Case




Normalized Thermal Transient Impedance, Junction-to-Foot


