




Gate Current vs. Gate-Source Voltage



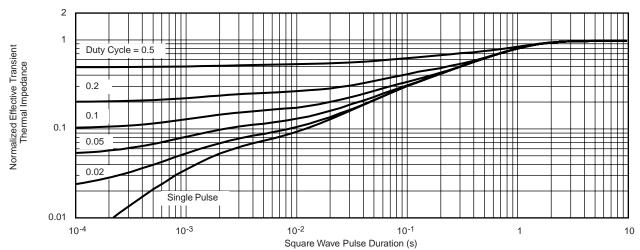




Normalized Thermal Transient Impedance, Junction-to-Foot

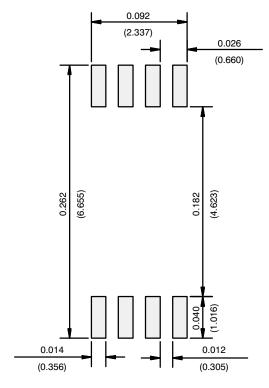
