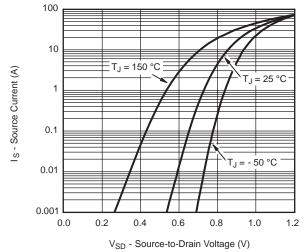

Single Pulse Power, Junction-to-Ambient



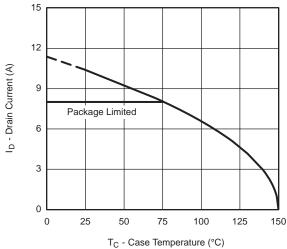

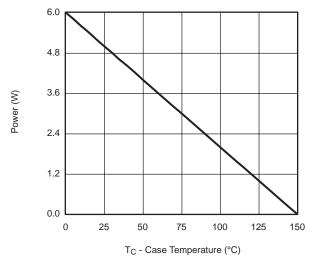

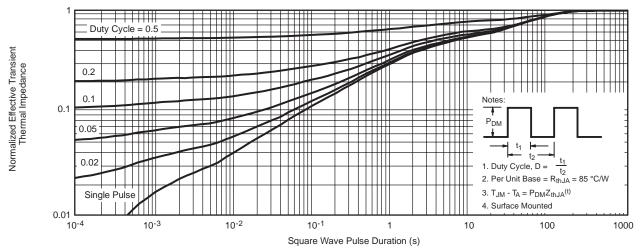


Power, Junction-to-Foot Power Derating, Junction-to-Ambient

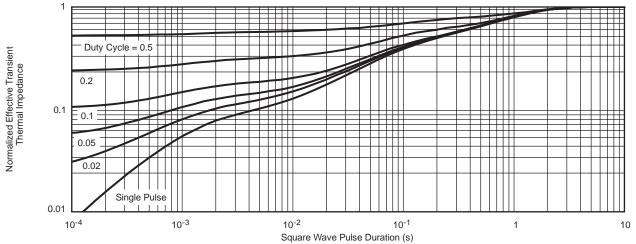

TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted



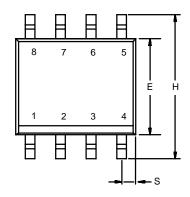
Normalized Thermal Transient Impedance, Junction-to-Ambient

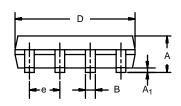


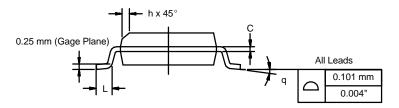
Normalized Thermal Transient Impedance, Junction-to-Foot

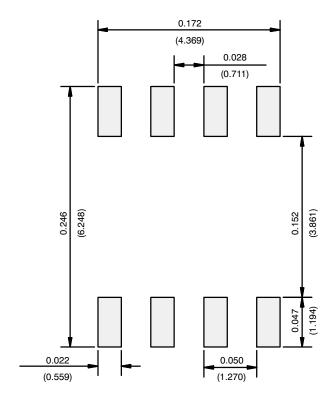
