








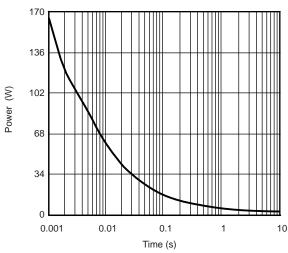
Source-Drain Diode Forward Voltage




Threshold Voltage

Single Pulse Power, Junction-to-Ambient








 $T_{\mbox{\scriptsize C}}$ - Case Temperature (°C)








T_A - Ambient Temperature (°C) **Power Derating, Junction-to-Ambient**



Normalized Thermal Transient Impedance, Junction-to-Ambient




Normalized Thermal Transient Impedance, Junction-to-Foot
