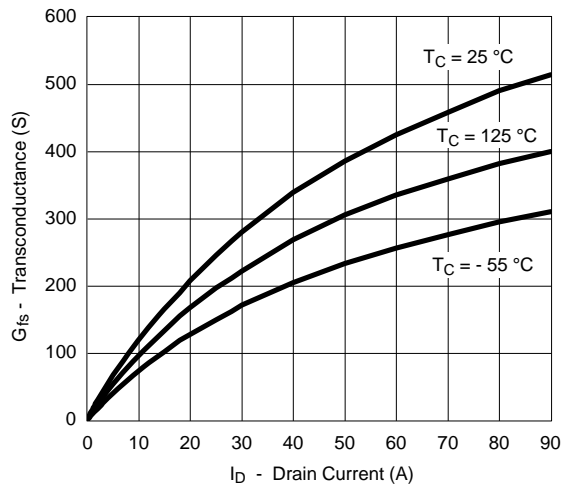

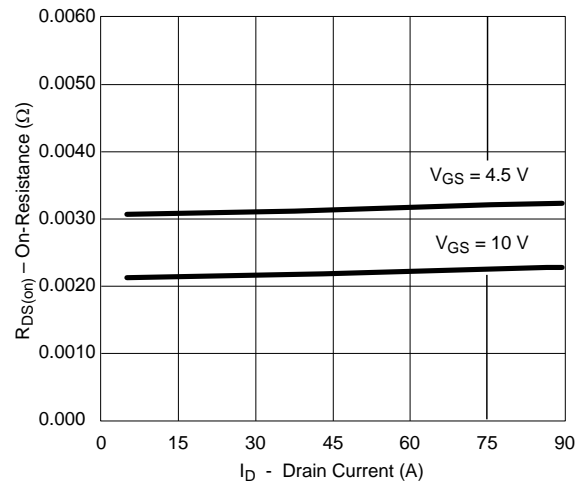

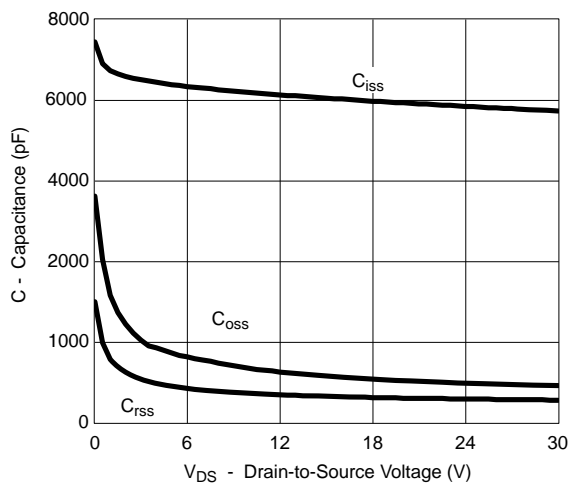
Transfer Characteristics

Gate Charge

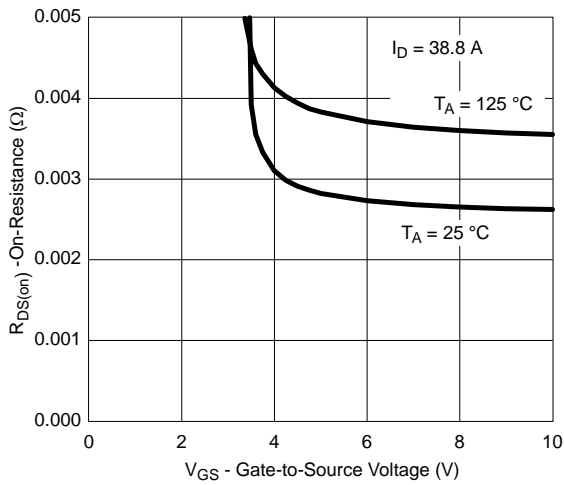

**On-Resistance vs. Junction Temperature**



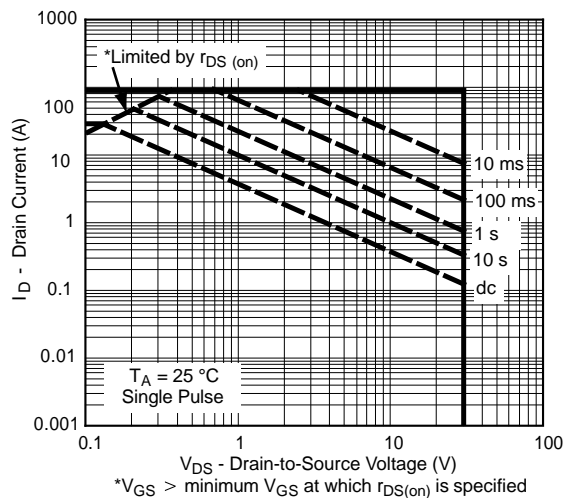
**Forward Diode Voltage vs. Temperature**



**$R_{DS(on)}$  vs.  $V_{GS}$  vs. Temperature**

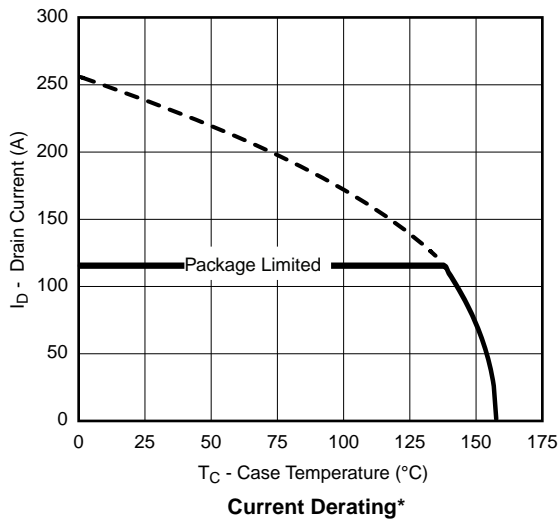


**Threshold Voltage**

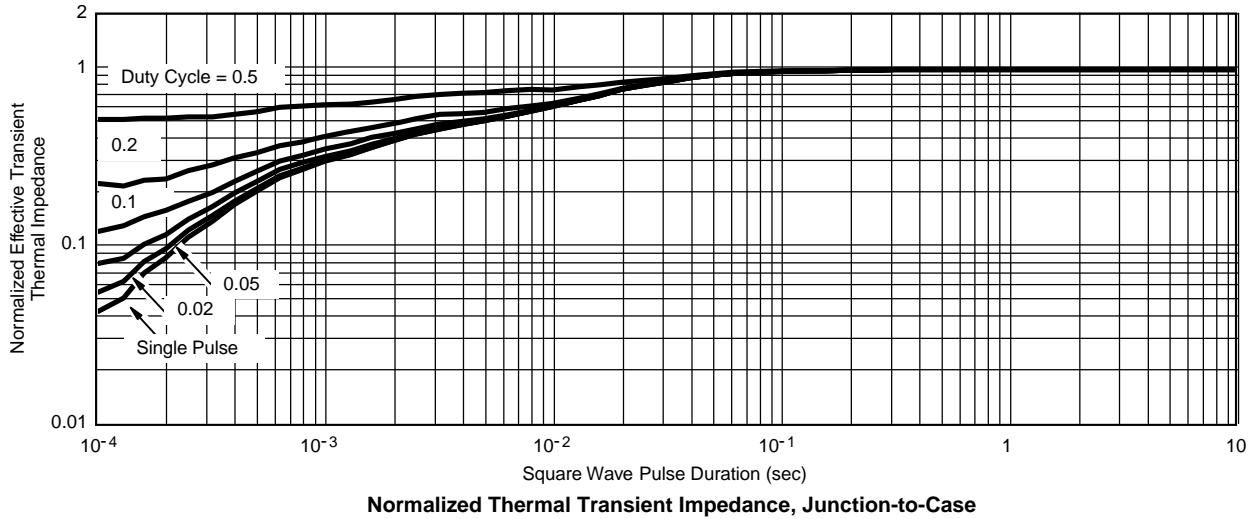


**Safe Operating Area, Junction-to-Ambient**

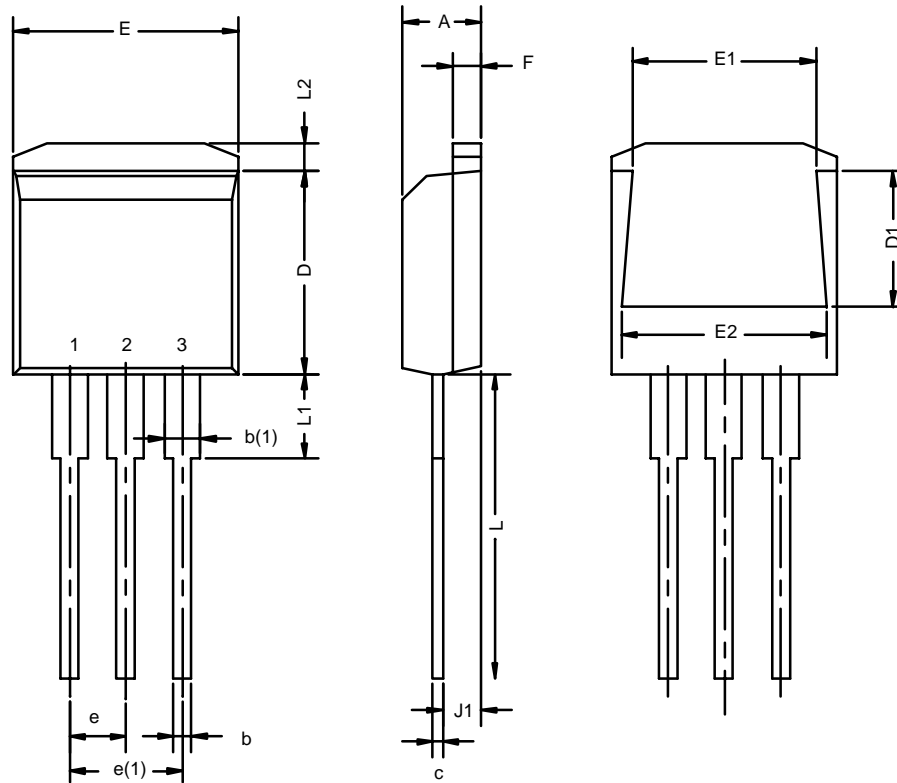
