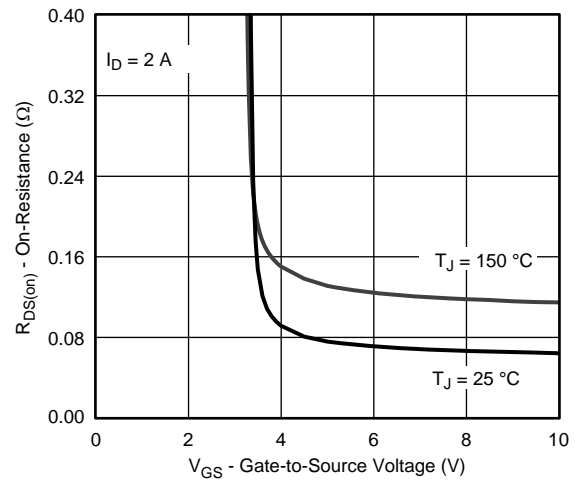

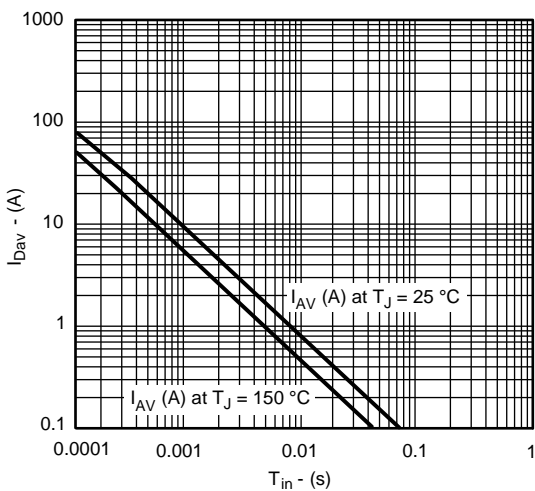
On-Resistance vs. Gate-to-Source Voltage



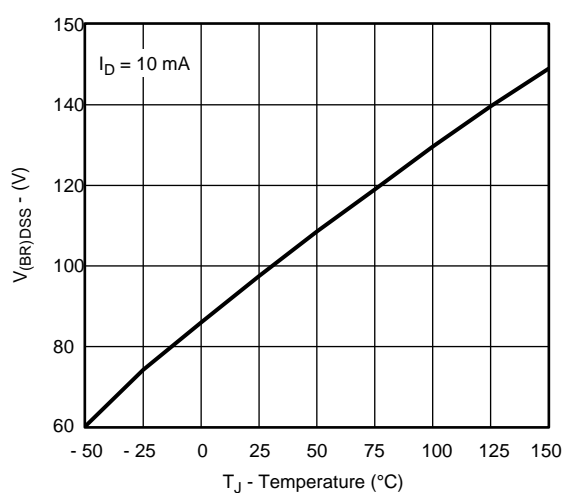
Source-Drain Diode Forward Voltage

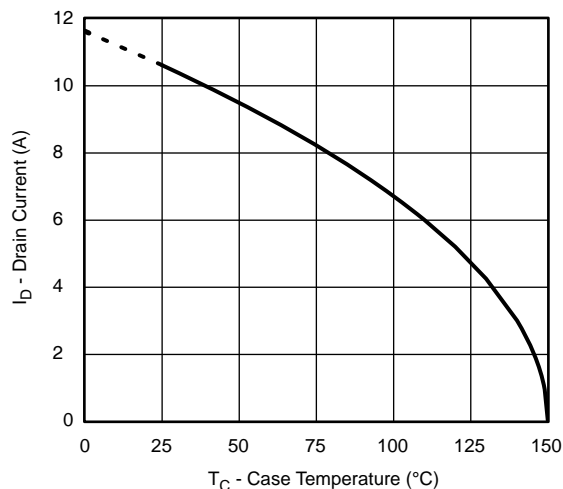
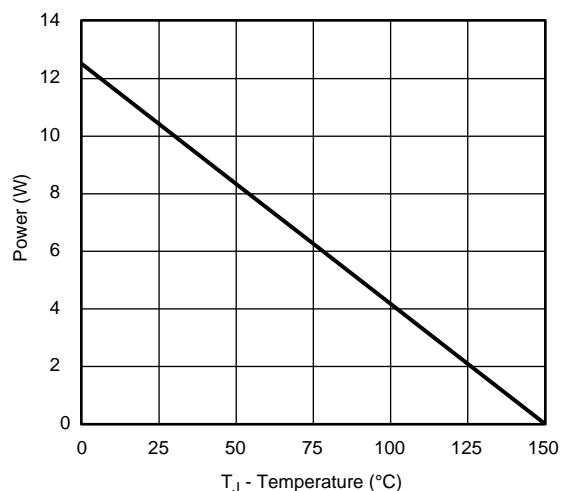
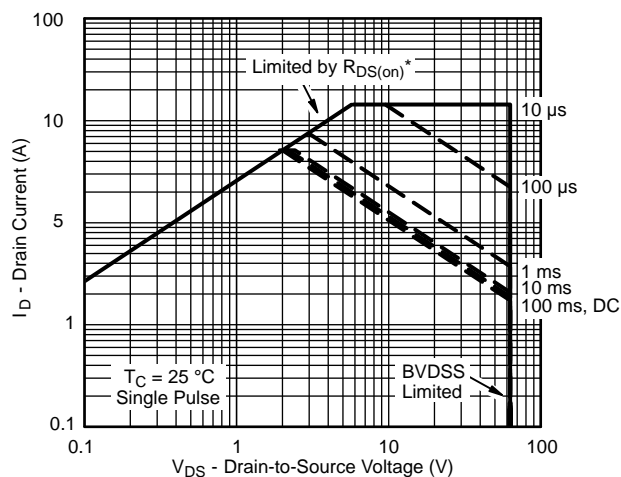
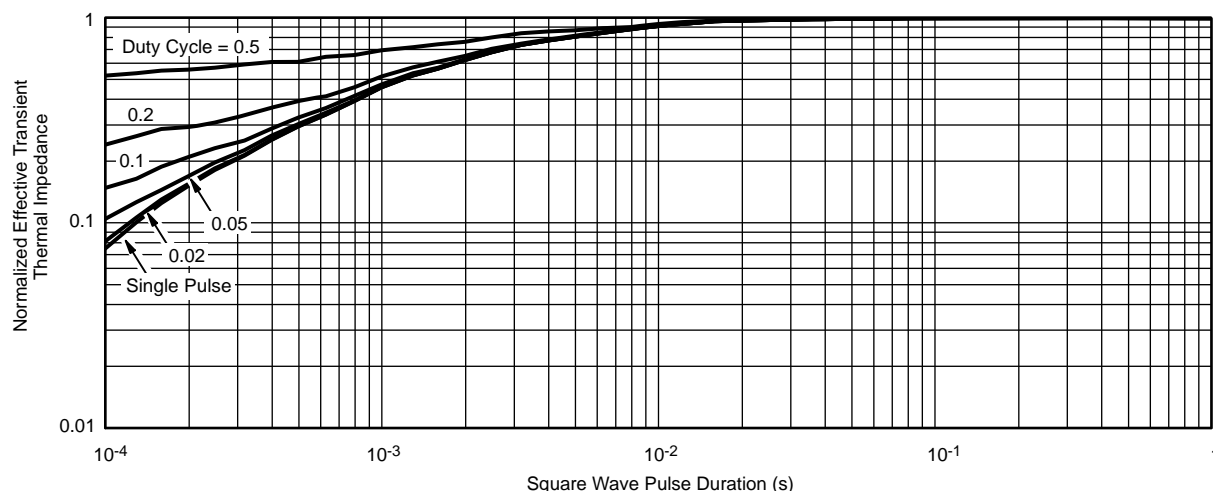


Single Pulse Avalanche Current Capability vs. Time

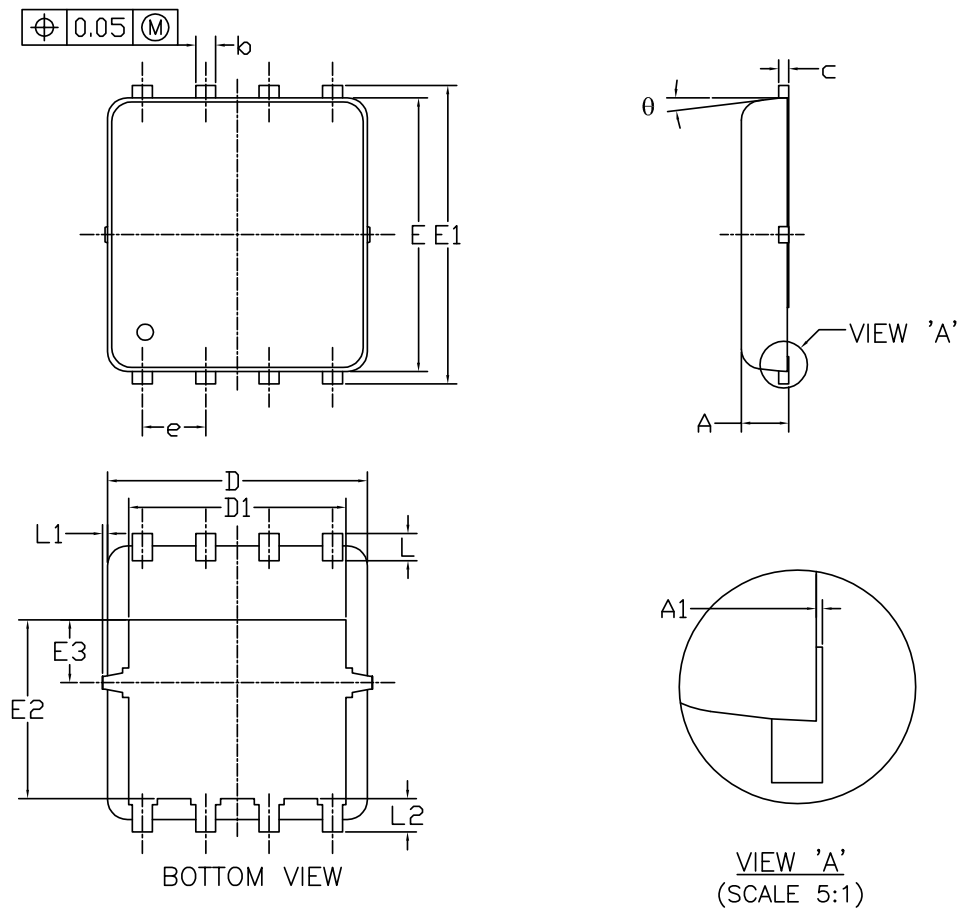


Drain-Source Breakdown Voltage vs. Junction Temperature

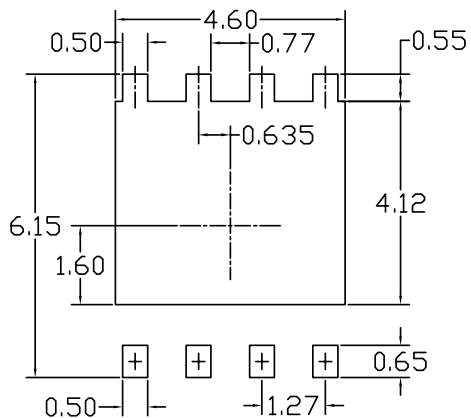
